More recently, Culture ministers have explicitly called upon the European Commission to investigate the possibility of setting up a specific mobility action for artists and culture professionals.</p> <p>Some opportunities for the international mobility of artists and/or cultural professionals exist with the support of public institutions, private foundations and/or NGOs, at local, regional, national, European and international level. At national level the situation is quite varied and at EU level, several EU programmes and funding instruments offer various opportunities for cross-border mobility activities that may include the cultural and creative sectors. However, none are specifically focused on the needs of artists or cultural professionals but rather on formal education, entrepreneurship or volunteering. The Creative Europe programme supports the mobility of artists and/or cultural professionals but only within cooperation projects and platforms.</p>

This aims to increase the level of media literacy in Europe by fostering the development of new educational materials or services, as well as the design of methods to raise awareness about the techniques used to create, distribute and amplify disinformation over the internet. The following activities are eligible:</p> <ul style="list-style-type: none"> • creation of multilingual online material including fact-checked news repositories and interactive educational tools; • development of tools and innovative methodologies to raise awareness about the danger of receiving and propagating disinformation, promote the use of fact-checking services and the reporting by social media users of disinformation; • promotion of social media campaigns and other relevant activities aimed at helping citizens to interact with digital media in a critically evaluative way; • community-led activities to tailor and make the above tools and materials accessible to minorities, low-skilled people, digital immigrants or people at risk of being socially marginalised. <p>Non-profit organisations, public authorities, international organisations, universities, educational institutions, research centres or profit making entities may apply. Consortia must consist of at least three legal entities from at least three EU member states. Consortia of more than three legal entities from different member states will be prioritised.</p> <p>The total budget is worth €500,000 and up to 60 per cent of eligible costs may be co-funded. Between two and five projects may be funded over up to 12 months.</p>

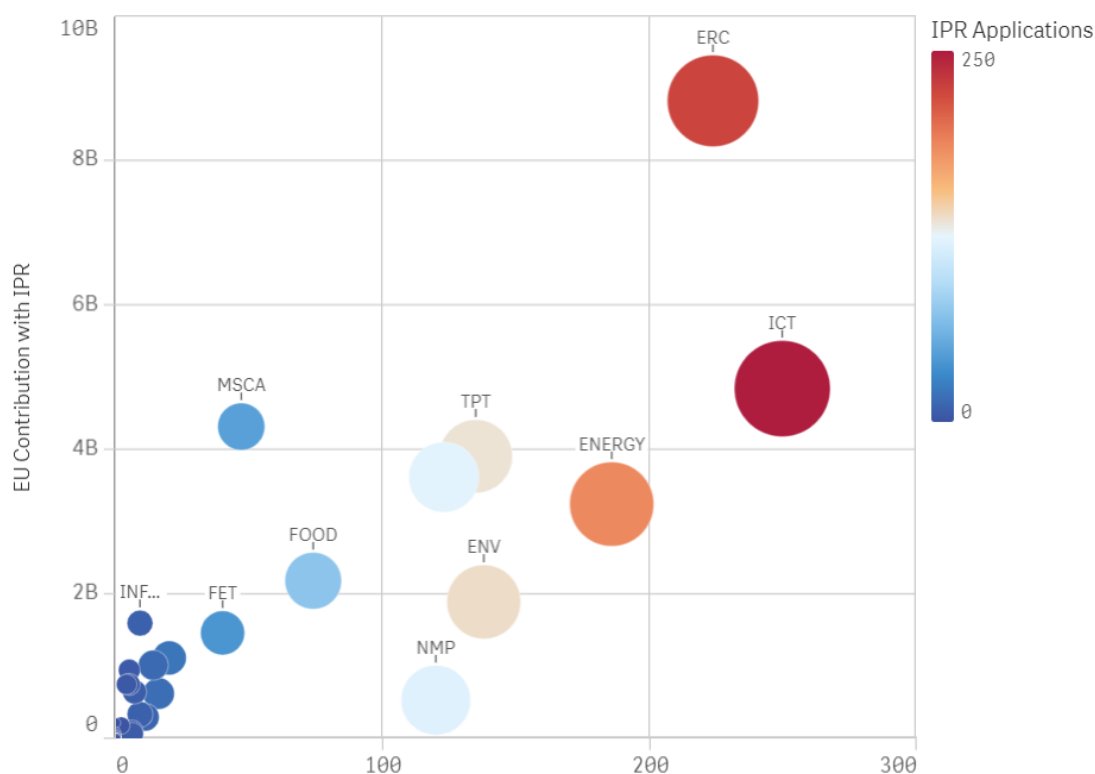
